Test fees are non-refundable. Completed test forms & payment must be submitted and post marked by the deadline. Applications will be processed on a 1<sup>st</sup>-come-1<sup>st</sup> served basis based on post mark. Priority will be given to Rye FSC Home Club members, then Associate Members, and then Guests. Test Sessions may be filled even prior to the application deadline. If session is oversubscribed, applications will be prioritized according to the date when both the completed application and full payment are received.

In order for an Associate Membership to be considered in effect for a particular test session, the membership application must be sent by the time you apply for the test session.

There will not be any credit or refund given for missed or cancelled tests except for the case of an injury when a doctor's note is provided.

If you are taking more than one test and two different coaches are putting you on at the Test Session, please submit two separate applications so the coaches' information is complete on each application. If you change which coach will put you on at the test after you submit your application, you must inform the Test Chair in advance of the test. **It is your responsibility to insure that the coach who is putting you on at the Test Session is CER compliant and registered with USFS for the 2011-2012 season prior to the test date.**

If you are taking more than one test at a Test Session, and taking the second test is contingent on the results of the first test, you will not receive a credit or refund for the second test if you are unable to take it because you do not pass the first one.

If you are placed on a waitlist, you will be informed approximately one week before the test. If you are put on the wait list by the Test Chair, you will receive a refund of your test fees if we cannot accommodate your test.

Information regarding the Test Session is communicated via email. Please be sure to check your emails regularly leading up to the test date. Information about test times and schedule will be emailed approximately three days prior to the Test Session.

Test Sessions are subject to change of date and/or time.
