2011/2012 ICE SUBSCRIPTION INFORMATION

SESSION INFORMATION

The Tuesday/Thursday ice is sold by yearly subscription. Because our ice sessions fill quickly purchase a subscription soon to guarantee a spot. Please note that the Tuesday & Thursday Sessions are full year subscriptions and by signing up you are **required to pay for all 2011/2012 sessions**. The first installment is due on Aug 15. Prior to Dec. 15, you will be billed for the second installment plus any price increase incurred from Ice rental with Rye Playland. The second installment is due on Dec. 15.

Walk-ons may be honored **only if space permits** and will be charged at \$25 per hour. If space is available, any walk-ons must be cleared with the session monitor before the skater takes the ice. If the session is completely sold out, walk-ons **will not** be permitted.

The *Thursday Stroking and Edgework Clinic Ice* will be offered as 2 separate subscriptions. You may sign up for either Clinic 1 or Clinic 2. Space permitting, you may walk on to this ice for \$15/session. Fees are for ice time only, coaching fees paid separately. Please note, if you are not also subscribed to the Moves and Freestyle session, you must clear the ice promptly after the clinic.

We limit the number of skaters on each session for skater safety. Sessions are also restricted to skating level (see table above). If more than the allotted number of skaters applies for any session, some skaters may not receive a spot. You will be notified if the session is filled. Ice subscriptions are awarded as follows:

Applications postmarked by the deadline of **August 15**.

- 1) Home club members re-subscribing to the same ice session as last year
- 2) New subscribers that are home club members
- 3) Associate Members re-subscribing to the same ice session as last year
- 4) New subscribers that are associate members
- 5) Space permitting, any applications postmarked after August 15

COACHES

All coaches previously approved to teach on Rye FSC subscription ice must complete the USFS coach registration process (includes background screening and liability insurance). Coaches should submit their liability insurance forms to Francine Vitale at the address below. Any coaches who would like to begin teaching on the Rye FSC subscription ice must receive prior approval from the Rye FSC Board of Directors. To be considered for teaching on these sessions Coaches must submit their resume and liability insurance certificates to Francine Vitale at the address below and allow 2 weeks for Board approval.

MEMBERSHIP

To skate on Rye FSC sessions, you **must** be a Home Club or Associate Member of the Rye FSC. Membership forms are available on the Rye FSC website at www.ryefsc.org. Please note you will not be allowed to skate on a session unless your membership is current and any past due fees are paid.

SUBSCRIPTION PAYMENTS

Subscription payments for the 2011/12 skating season should be remitted as instructed on the subscription form. The first payment is due **August 15** and the second payment is due **December 15**. A skater will not be allowed to skate unless his/her account is in good standing. Failure to keep an account current can result in the skater being excused from a session and their spot sold to another skater. Contact the Rye FSC Session Administrator at RyeSubscription@aol.com with questions. The walk on \$25.00/hr fee is due prior to the skater taking the ice. Any returned checks will incur a fee of \$25.00.
